Registration



• Payment

 Bridge Kidz is a tuition-free program. We require no weekly or monthly recurring fees for the summer or after-school program.

• Registration

 School-age children currently in grades K - 5 may be enrolled. BK Registration is open to all, it is first come, first serve until slots are filled.

• Withdrawal Policy

• In the event a parent would like to withdraw their child from Bridge Kidz, one-week advance notice to the center is required.

Insurance

Parents are responsible for providing primary insurance coverage on stuedents for any incidents incurred while attending Bridge Kidz.



Drop-Off & Pick-Up

• Drop-Off

• Please sign your child in and leave them in the care of a Bridge Kidz staff member. Please print your full name every time.

Afterschool

 Bridge Kidz provides afterschool transportation from PPSD to Bridge Kidz's location after-school.

Summer

• Drop-off during Bridge Kidz summer program begins at 7:15 am.

• Pick- Up

- All children must be signed out of the facility by an authorized individual before pick-up.
- All children must be picked up by 6:00 pm.

Authorized Check-out list

- Bridge Kidz will only release children to responsible persons for whom the childcare facility has written authorization.
- Bridge Kidz reserves the right to ask for IDs to confirm identity
 - After initial registration, please see a Bridge Kidz staff member to add someone as an authorized checkout person.

Late Fees

- Bridge Kidz closes at 6:00 pm, therefore, all children must be picked up before or at 6:00 pm daily. At 6:01, parents will be charged a late fee.
 Bridge Kidz's late fee is \$1 for every minute after 6:00pm.
- If no one from the authorized check-out list has picked up the child by 6:40 pm, Bridge Kidz will then contact the authorities.



Personal Belongings

Afterschool:

• Children are permitted to bring their backpacks, and lunchboxes to Bridge Kidz after school. They will be stored in a designated location in our facility. Please be sure your children have all of their belongings with them upon pick-up

Summer:

Children are permitted to bring a small lunch or a small personal bag with them to Bridge Kidz summer program. If your child brings a snack bag, they will need to wait until the appropriate time on the schedule before consuming.

Strictly Prohibited Items:

Please do not bring the following items to the program:

- Weapons of any sort fake or real!
- Toys & stuffed animals
- Expensive clothes
- Nail polish/ makeup
- Valuable items
- Fidget spinners

Bridge Kidz is not responsible for stolen or lost items. Please ensure your child has all of their belongings with them upon pick-up daily.



Program & Activities



Photography

Bridge Kidz prohibits the photographing of a child without parental consent. During registration, each parent is given a consent form to restrict or approve the photography of a child.



Outdoor Play

children will participate in outdoor play every day, weather permitting. Shorter periods of outdoor playtime may be scheduled if it is too hot, too cold, or raining outside. All children are expected to participate in all play and activities unless a doctor's note is on file specifying medical restrictions or limitations.

Records

Each child's record shall contain a statement signed by the child's parent, indicating that they have received a summary of licensing standards and other materials designated by the licensing agency for such distribution.



General Schedule

Parents can refer to Bridge Kidz's schedule posted on the bulletin board by the front door for a more detailed outline.

SNACK TIME:

- In accordance with USDA nutrition standards and meal pattern guidelines for after-school programs, we will provide water and at least one snack, per child, per day.
- children may also eat a snack from home or finish a sack lunch but may only do so during the scheduled snack time.
- Food cannot be shared and must not contain nut products.

HOMEWORK TIME

- Bridge Kidz is NOT a tutoring program.
- We will provide a time and setting conducive for children to complete homework.
- Time limits for homework sessions will be set according to age/grade level appropriateness.
- children & Parents are responsible for properly checking for homework assignments.
- children who do not have homework may participate in alternative supervised activities.

Health & Emergency Procedures

Procedures for storing and giving a child medication.

- A form giving Bridge Kidz permission to treat your child in case of an emergency, when the parent can not be reached, must be signed and given to Bridge Kidz. Other important contact information and procedures in the event of an emergency will need to be included.
- BK will not hold or administer prescribed medications.

Policy for reporting suspected child abuse.

- Bridge Kidz staff is required by law to report any suspected child abuse, and/or unsafe environment.

Provision for emergency medical care, and treatment of illnesses and accidents, which include:

- Parents of registered children at Bridge Kidz will be immediately notified of any serious illness, accident, or injury to the child.
- In the event of a crisis, or an emergency situation, the parent of the child, and the correct emergency responders will be called immediately.

• Dangers Situations

 BK prepares for dangerous situations, including but not limited to, dealing with violent individuals, individuals entering the facility with weapons, bomb threats, or conditions posing an immediate threat to children by way of drills.

Bridge Kidz performs regular safety drills with children.

Discipline Policy -

Bridge Kidz has a disciplinary strike system. Please talk with your child about their behavior and review the policy with them.

Strike Number	Consequence
Strike 1	Warning
Strike 2	Child Conference about Behavior
Strike 3	Parent Phone Call about Behavior
Strike 4	In-Person child and Parent Conference
Strike 5	One Day Suspension from Program
Strike 6	Parent Meeting about Next Steps



Discipline Policy cont.

Unacceptable Behavior Includes, but is not limited to:

- Use of profane language
- Inappropriate gestures or movements
- Bullying, of other children
- Inappropriate physical interactions with other children
- Disrespectful behavior and attitudes toward counselors

Acceptable Discipline Measures Include:

- Positive guidance and redirection are the two disciplinary responses shown to the children. Repeated praise for appropriate behavior will help maintain a harmonious classroom.
- Children may be put in 'time-out' for a brief period of time (one minute per year of age) if the child has lost control of his or her behavior.
- A child may be given a strike as a consequence of unacceptable behavior. A parent will be notified any time a child is given a strike.

Unacceptable Discipline Measures

- Bride Kidz DOES NOT use corporal punishment at this facility. No child is to be spanked, popped, or shaken by the teacher.
- If the teacher has tried all approved methods, the child may be brought to the director and appropriate discipline worked out by the director, teacher, and parent.

BK reserves the right to review each offense on a case-by-case basis. The nature and severity of the behavior will be carefully considered in order to determine the most appropriate consequences. Our goal is always to respond in a way that supports the safety, wellbeing, and growth of all students in our care.



Bridge Kids (BK) Code of Conduct

For K-5th Grade Students & Families

- At BK, we're committed to creating a safe, kind, and fun environment where all kids can learn and grow. As a tuition-free program that exists to bless the community and uplift working families, we ask students and families to partner with us to protect our shared space.
- We are committed to maintaining a safe and respectful environment and to protecting the wellbeing of every child in our care.

Student Expectations

- BK students are expected to:
- Listen and follow directions.
- Keep hands, feet, and objects to themselves.
- Use kind and respectful language.
- Take care of materials and shared spaces.
- Stay with the group and in approved areas.
- Include others and treat everyone with kindness.
- Respect personal space and privacy students must stay fully dressed and keep private parts covered at all times.



Bridge Kids (BK) Code of Conduct

• Family Responsibilities

- We ask parents/guardians to:
- Get students to and from BK on time.
- Keep emergency contact info up to date.

• Review this Code with your child.

- Support BK staff with behavior expectations.
- Communicate with us if concerns arise—we're here to help!

• Behavior Support

- BK uses a positive, restorative approach. If behavior becomes a concern:
- Students will be redirected and guided to make better choices.
- Families will be contacted if the issue continues.
- Ongoing issues may result in suspension or dismissal to ensure the safety and wellbeing of all.



Alternative School Policy

At Bridge Builders Leadership Initiative, we are committed to fostering a nurturing and secure environment for all our participants. It is imperative that our afterschool programs maintain a setting that supports both educational and personal growth.

Policy Statement

 Any student who is placed in an alternative school as a disciplinary measure by their primary educational institution will not be eligible to attend the Bridge Kidz Afterschool Program. This policy is in place to ensure that all students in our programs can benefit from a cohesive and constructive learning environment without disruption.

• Re-Eligibility

Once a student successfully completes their tenure at an alternative school and returns to a traditional educational setting, they may be reconsidered for re-admission to the Bridge Kidz Afterschool Program. This reconsideration will be contingent upon a review of the student's conduct in the alternative setting and a positive recommendation from their school.

Compliance with this policy is mandatory for participation in the Bridge Kidz Afterschool Program.

Dear Parents,

The Regulations Governing Licensure of Child Care Facilities require that child care providers supply you with a summary of the Child Care Regulations that govern the licensure of child care facilities. You will find that information below.

The Child Care Regulations are the rules and regulations that each child care facility in Mississippi must follow in order to maintain their Child Care License. You, as a parent, are entitled access to these regulations. Among the subjects covered in the Child Care Regulations are:
